

OUTSTANDING SIGMA OF THE SOUTHERN REGION

A. General Membership OSSR Requirements

1. Must be an alumni brother in good standing with local graduate chapter.
2. Must be nominated by local alumni chapter
3. Must be an alumni brother in good standing with state.
4. Must be an alumni brother in good standing with the Region.
5. Must be an alumni brother in good standing with International Headquarters
6. Must have been a member of Phi Beta Sigma Fraternity, Inc., for at least Five (5) years.
7. Must have a strong record of Service to Sigma
8. Must complete the application and be approved by his State.
9. Must be Present at the Regional Conference at the time of induction

B. Special Membership

1. DSC Member relocating to the Southern Region
2. Brother is designated as "Outstanding" from previous regions and relocating to the Southern Region

C. Limitations

1. Each State may only submit two names for consideration at the Regional Conference

D. Evidence of Membership

1. Each brother designated as an Outstanding Sigma of the Southern Region will be presented with a pin and certificate at the time of induction.

Membership Guidelines

THE OUTSTANDING SIGMAS OF THE SOUTHERN REGIONS (OSSR) is the highest honor given to a brother of this fraternity at the Regional Level. This honor is granted to a deserving brother by the members of his State pending approval of the Southern Region's body during their annual Regional Conference. For a member to receive this honor, he must be recommended by his Alumni Chapter, in writing, to his State's OSSR Committee. The following criteria are to be used:

- **REQUIREMENTS:** To be considered for membership into the OSSR, a brother must meet the following requirements:
 - A current financial member of an Alumni Chapter of the Fraternity (Local, State, Regional, and National).
 - A strong Alumni and/or Collegiate leadership record.
 - A strong State leadership record.
 - A strong Regional and/or National leadership record.
 - A minimum of five (5) years of service to the fraternity.
 - Exemplify a strong sense of brotherhood.
 - A strong Professional/Occupational and/ or Community Service record.
 - A letter of recommendation and completed Application Form from the Alumni chapter of which the brother is a member. The application should be typed or printed neatly in ink and must be signed by the local Chapter president and local Chapter Secretary. If submitting for region consideration, the application must be signed by the State (OSSR) Committee Chair and State Director. Attachments are acceptable if needed. Appearance does count toward final Application score.
- **QUALIFICATIONS:** To qualify for membership in this chapter, a brother must be involved in the promotion of, but not limited to, two (2) or more of the following Phi Beta Sigma programs/activities during his tenure as a Sigma Man on an ongoing basis:
 - Bigger and Better Business
 - Education
 - Social Action
 - Sigma Beta Club/S.A.T.A.P.
 - Sigma Shadows' Program

- Sigma/Zeta Relationships
- Giving unquestionable service to the organization as deemed out of the realm of the individual's responsibility but due to his own devotion and commitment to Service and Humanity.
- Any other meritorious service recognized by his Chapter, State, Region, and/or National as being deserving of such honor(s)

- **THE SELECTION PROCESS:**

- The Alumni Chapter from which the brother is a member must submit a letter of recommendation with a completed application to the State OSSR Committee on or before the designated deadline each year. This application/citation is to be used for STATE AND REGIONAL SUBMISSIONS. If submitting for the State OSSR, the same protocol must be followed as for the Region.
- The OSSR Committee will make the selection based on the guidelines set by the committee.
- State members of the Outstanding Sigmas of the Southern Region Chapter will present their candidate at their State Conference for ratification by the State body. Once ratified by the State, the State Outstanding Sigmas of the Southern Region Committee will decide whether to forward the application for Regional Committee consideration.
- The candidate's letter of recommendation and application will be presented to the OUTSTANDING SIGMAS OF THE SOUTHERN REGION for acceptance and to the State/Regional body for RATIFICATION.
